# NSW POLICE FORCE - FIREARMS REGISTRY B709B

## Application for a B709B Police Confirmation for Prohibited Weapons

This form should be used for obtaining the police confirmation required to accompany an application to Australian Customs to import prohibited weapons and articles into Australia. Please use BLACK PEN and CAPITAL LETTERS to complete this form.

Prohibited weapons and articles listed in Schedule 2 of the *Customs (Prohibited Imports) Regulation 1956* will be seized by Australian Customs unless the importer has a B709B police confirmation allowing them to possess the weapon or article. B709B import certificates are issued by the Firearms Registry for those weapons and articles listed in Schedule 2 of the Customs legislation that are also listed in Schedule 1 of the *Weapons Prohibition Regulation 2009* or not regulated at all in this State.

The Table in this application lists all the prohibited weapons and articles that require a B709B Police Confirmation for importation. The correct items must be selected by the applicant.

**NOTE:** The onus is on the importer to properly and accurately identify the item they wish to import. If you are unsure whether a B709B is required for the item you wish to import, you can obtain classification details from the Australian Customs by forwarding details and photographs to [weaponspolicy@customs.gov.au](mailto:weaponspolicy@customs.gov.au).
